is therefore an important and appropriate addition to the management systems that have been in place for many years.

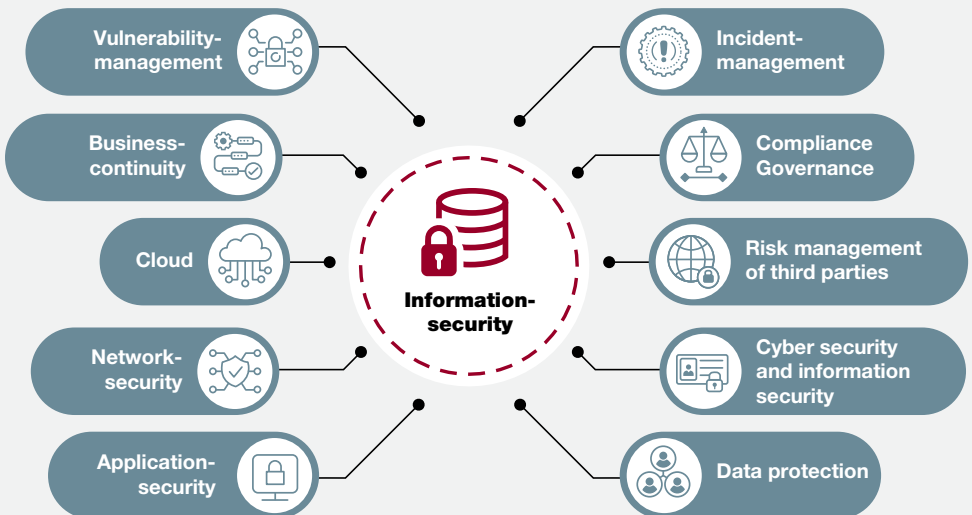
## An ISMS according to ISO / IEC 27001
